We are here to help you select how you want to celebrate your loved one as you feel appropriate, while being financially realistic and remaining within your budget. Therefore, we do not wish for you to spend more than you can afford. For your convenience, we accept the following forms of payment: check, credit or debit card, money order, cashier's check, insurance assignment of a verifiable life insurance policy*, payment by a forwarding or receiving funeral home or a pre-need or pre-paid funeral plan that is in good standing. We do not accept cash. The balance of the funeral contract should be secured before the date of the funeral service or cremation, unless other arrangements have been approved by CCC Management.

**We have a fee of 4% or \$200.00 for processing life insurance, depending on contract balance. Balances over \$3600 will pay 4%; balances under \$3600 will pay \$200.*

PRE-PLANNING ASSISTANCE

Complete Care Cremation provides complete pre-planning assistance. Pre-planning gives you the ability to purchase a funeral plan in advance of the death and lock in the prices for the goods and services provided us. Any future price increases for selected items would not affect your loved ones at the time of your death, as long as the policy is in good standing. We will also honor on a case-by-case basis pre-arrangements from other funeral homes. If you are not prepared to financially secure your funeral plans, you can still provide us with biographical information to keep on file without any financial obligation.

A. Basic Services of Funeral Director and Staff **\$1,395.00**

The fee for basic services of the funeral director and staff includes, but is not limited to: staff available for request of services, legal arrangements including preparation and filing of necessary authorization permits, reporting death to the local registrar, reporting death to the State of Texas and SSA via the state's software for vital statistics, and ordering death certificates, coordination with third-parties providing other portions of the funeral (e.g., cemetery, crematory and others) and the utility vehicle used on services to transport equipment. This fee also covers overhead charges, such as legal licensing fees, insurance, book and record keeping and administrative expenses.
